As we get further into the holiday season I hope everyone had a Happy Thanksgiving with family and friends, and didn't gain too much weight eating all that great food. Our speaker for December is Bernie Buckley who was motivated to take part in the "Longest Day Program" sponsored by the Alzheimer's Association on June 21, 2013. Bernie will take us on a journey to the highest summit of the African Continent as he goes through the highlights with photos and his story of his climb of Mount Kilimanjaro. Bernie is an Eagle Scout, retired military, and science teacher for 14 years. You don't want to miss the breathtaking view from the top of Mt. Kilimanjaro, so plan to attend and bring a friend.

As most of you have already heard, the 2014 cost-ofliving adjustment (COLA) for millions of retired and disabled Americans will be 1.5 percent. Social Security beneficiaries, civil service annuitants and military retirees will be among those receiving the adjustment in their January 2014 benefit payments. For those of you enrolled in Medicare Part B the monthly premium in 2014 will be \$104.90, same as 2013. The Medicare Part B deductible also remains unchanged at \$147.00.

On a more serious note, it is important for you to continue to write, email or call your Senators and Representatives in Congress urging them to counter the claims of the anti-Social Security lobby and their allies in Congress who believe the present COLA is too generous and are calling for the adoption of the "chained" Consumer Price Index (CPI). A study of the "chained" CPI shows this so-called "technical tweak" would amount to a significant cut in the benefits for millions of Americans receiving federal annuities and social security payments. LEGISLATIVE REPORT Kathy Siggins (301-829-2462)



We were honored to have NARFE National President, Joe Beaudoin (above) and his wife, attend our November luncheon. He stressed how our NARFE membership numbers are going down and the need to recruit more members. He also stressed the importance of contacting our elected officials to oppose legislation that is harmful to the federal community. He mentioned that only 1% of our total membership, just under 300,000 made their calls to their representative and two senators on National Call Day. On Oct. 30, the House-Senate budget conference committee, tasked with reaching agreement on government funding levels through the remainder of the fiscal year, held its first meeting. The committee could consider changes to longer-term spending and revenue, such as increases in retirement contributions for federal employees or reductions to future cost-ofliving adjustments to federal annuities. The work of the conference will happen out of public view, but conferees must hear from fellow members of Congress that the Chained CPI is an unfair reduction in earned benefits.

NARFE members are urged to use the Legislative Action Center on the NARFE website to tell their congressional delegations, "<u>Enough is Enough</u>."

A Rally to protest the Chained CPI was held in front of the White House on November 14. Members of NCPSSM, National Organization of Women, Military Officers Association of America, Global Policy Solutions, Social Security Works, and AARP joined NARFE in opposing the Chained CPI. If the change were adopted, Maryland would see 300 jobs lost, a \$3.7 billion benefit cut (by 2023) and \$54 million economic loss by 2015. Individuals attending the Rally held up signs containing statistics from each state. Approximately 75 to 100 individuals attended the Rally.

## MEMBERSHIP REPORT Bill Elsen, Membership (301-663-4027)

We did not gain any new members this past month. Three members transferred out of our chapter. They are Alfred Gonzales, who moved to Chapter 0825 in South Carolina, and George Banko and Arnold Trevett who both transferred to Chapter 2363, the e-chapter. Both Mr. Banko and Mr. Trevett are listed under the New Membership Incentive Program; curiously neither of them had ever been listed in any previous monthly report as having been assigned to our chapter. Two members were dropped for non-renewal of their membership. They are Maurice Daugherty and Ellen Meyer. If you know either of these members please contact them and encourage them to re-join. One member, Doris Egge, voluntarily cancelled her membership. In the category of New Prospective Members listed in the Chapter 409 Activity Report (M-112) by the National Office for October there were 12 names of people who live in Frederick County. I will be writing to them, inviting them to join our chapter as 409 members. This gives us a net loss of two members (not counting Mr. Banko or Mr. Trevett mentioned above). Hopefully we will get some of the 12 New Prospective Members to join us.
