# **November Is FEHB Month**

The government is currently operating under a continuing resolution, which expires on December 8, leaving Congress with a tight window to keep the government funded. Congress could go multiple routes in dealing with this process, most likely passing another short-term resolution. However, at some point fiscal year 2018 will have to be fully funded, perhaps with a push by Congress to have this resolved by the end of the year.

NARFE is particularly concerned about the possibility of another two-year bipartisan budget agreement, which could use federal benefits as an offset for raising sequestration budget caps. Congress passed such bipartisan agreements in 2013 and 2015. The 2013 agreement required increased retirement contributions for newly hired federal employees as the budget offset; feds were spared in the 2015 agreement.

This time, all of the proposals NARFE has been successfully fighting are on back on the table: ending the FERS Annuity Supplement, eliminating or reducing COLAs, decreasing the value of the Thrift Savings Plan funds and increasing retirement contributions for current employees.

NARFE members must again mobilize and take action to protect their earned pay and benefits. Take a few minutes to contact your legislators and tell them that the federal community has paid more than its fair share and should not be targeted again! This is very easy to do through a link on the *narfe.org* website. It's important to make your voice heard and counted.

## **House Passes Tax Reform Bill**

The House passed its version of tax reform by a partyline vote of 227-205, handing the next move on tax reform to the Senate. This bill did not cut federal retirement or health benefits, but NARFE is closely monitoring the process of tax reform for potential implications on the federal community.

One area of major concern NARFE has with the House bill is the repeal of the medical expense deduction. Millions of taxpayers over age 65 use this deduction to reduce large out-of-pocket medical expenses, such as nursing home care, which can potentially bankrupt consumers. The Senate bill does not currently contain a repeal of this medical expense deduction. NARFE will work diligently to oppose the repeal of this deduction

### LEGISLATIVE David Carmack (240-578-4965)

The Thrift Saving Plan Modernization Act of 2017 has been approved by Congress and sent to the President. This bill allows TSP participants, who are retired or over 59 ½ and still working, more flexibility over withdrawals from the TSP. The withdrawal provisions of the bill, if approved by the President, will come into effect upon issuance by the Federal Retirement Thrift Board, which oversees the TSP. The legislation gives the Board a two-year period in which to issues the regulations.

Unless extended, the short-term continuing resolution to fund the government and raise the debt ceiling will expire on December 8, 2017. The debate over funding the budget and raising the debt is likely to be very contentious and is likely to force decisions regarding the budget proposals affecting federal employees and/or federal retirees, such as eliminating the Federal Employee Retirement System Annuity Supplement, decreasing or eliminating cost-of-living adjustments, and reducing the government contributions toward federal health insurance premiums. You should follow very closely this debate for it may affect you. NARFE is actively engaged in protecting benefits for federal employees and retirees, and it needs your support to do so.

Mr. David Hurka, FEHBP Account Management and OPM Relations at CareFirst BlueCross BlueShield spoke to the membership during the November luncheon. He provided an overview of OPM driven changes to FEHB plans and highlighted BlueCross BlueShield changes. Members also heard from representatives of Kaiser Permanente, GEHA, APWU, and AETNA. 
