You are regularly using your Frederick County blue recycling bin, right? Have you ever wondered or found yourself confused about what may or may not be recyclable? Have you ever thought to yourself, "Well, this is plastic, and that makes it OK to go in the bin." The answer here is maybe yes, maybe no. We have with us for our February meeting the director of the county recycling program, who can tell us everything we need to know about recycling and what we can do to be proper recyclers.

During the next few months you will be hearing more and more about the census count of 2020. When it's time to respond, most households will receive an invitation in the mail, with the option of responding by either mail, phone, or online. There will be six demographic questions to answer, with the data collected for statistical purposes only. Why is this so important? Census data impacts us all in many ways: determining representation in Congress, as well as defining local legislative districts; it is the basis for allocation of Federal funds for the next decade for the state, county, and communities, for programs such as first responders, supportive services for the elderly, libraries, public health, school construction, and highway and transportation projects. Every year the Federal government allocates more than \$675 billion to fund such programs. Every person needs to be counted! From the last census, Frederick County received funding of \$1,800 per person counted, about \$18,000 over the ten year period. It is estimated that the loss to the state for persons not counted was about \$26.6 billion. Completing your census form ensures that Marylanders receive the support needed to live, work, play, and grow. Responding is critically important, easy, and safe. Your responses are used only to produce statistics and cannot be used against you in any way by any government or law enforcement agency.

Tax season is approaching and many of us are in the process of gathering the 1099's and all other documents needed for preparing our returns. Chapter 409 sponsors a Volunteer Income Tax Assistance (VITA) group that does both Federal and Maryland tax returns for seniors and low/moderate income persons, at no cost. this service, the main one being an income cap of \$70,000. If the VITA group can help you with your taxes, call for an appointment. The VITA sites are Frederick Department of Aging on Taney Avenue (301-600-1605), and for residents of northern Frederick County, the Thurmont Library and the Seton Center in Emmitsburg (410-218-5227).

In the last THE KEY NOTES, I called your attention to the new law allowing Federal employees paid parental leave of 12 weeks for births, adoptions and foster placements on or after October 1, 2020. The new law amended Title 5 of the United States Code (USC), which has the standard set of Civil Service laws covering personnel policies, including leave. Most, but not all, Federal employees are covered under Title 5. For example, employees of the Federal Aviation Administration come under Title 49, USC, and are not covered. Many medical personnel of the Department of Veterans Affairs fall under Title 38, USC, and may not be covered. The Transportation Security Administration (TSA) operates mainly outside of Title 5. Thus, the TSA screeners are covered by the new law, but other TSA employees are not covered. Employees of financial regulatory agencies that operate under the Financial Institutions Reform Recovery and Enforcement Act are also not covered. This is not a complete list of all Federal employees not covered. The attempt to amend the new law to cover all Federal employees failed.

In the last THE KEY REPORT, I stated that the National Defense Authorization Act stopped the President's Office of Personnel Management (OPM) reorganization plan. That Act merely postponed that reorganization plan from advancing at least until 180 days after a year-long study by the National Academy of Public Administration of looking at the challenges facing OPM and recommending solutions.

NARFE is still encouraging its members to contact their representatives to replace the annual cost-of-living adjustment (COLA) used in determining Social Security and Federal retirement payments from the current Consumer Price Index for Urban Wage Earners and Clerical Workers (CPI-W) with the Consumer Price Index for the Elderly (CPI-E). This change would ensure more accurate annual COLAs for seniors. The Fair COLA for Seniors Act, H.R. 1553, which has been introduced in the House of Representatives, does this.

NARFE's National Walk teams raised nearly \$75,000 in 2019 for the Walk to End Alzheimer's. This impressive total will be credited to NARFE's national goal, to raise \$14 million by the end of 2020. Registration for the 2020 Walk to End Alzheimer's is now open.

The Alzheimer's Semipostal Stamp which expired on November 30, 2019, is currently pending reinstatement by the U.S. Postal Service (USPS). Senator Chris Van Hollen along with his colleagues, Senators Edward J. Markey (D-MA) Susan Collins (R-ME) and Shelley Moore Capito (R-WV), successfully included language in the final Fiscal Year 2020 spending package that directs the USPS to continue selling the Alzheimer's semipostal fundraising stamp. Senator Collins said, "As a founder of the Alzheimer's Task Force in the Senate and a senior member of the Appropriations Committee, I recently helped secure a \$350 million increase for Alzheimer's research, bringing the total to \$2.8 billion. By allowing Americans to continue to purchase Alzheimer's research stamps, our legislation will build on this funding to support the NIH's efforts to combat this devastating disease."
