Legislative Report (David Carmack • 240-578-4965)

The National Defense Authorization Act for Fiscal Year 2022 now provides

a paid parental bereavement leave benefit for Federal employees for up to two weeks of paid time off, if an employee experiences the death of a child. OPM has directed all Federal Employee Health Benefits (FEHB) carriers to cover over-the-counter COVID-19 tests meeting the statutory criteria under Section 6001(a) of the Families First Coronavirus Response Act, including tests that have been approved for use without the involvement of a health care provider. But FEHB carriers are not required to provide coverage of testing that is for employment purposes. Additionally, every home in the U.S. is eligible to order 4 at-home COVID-19 tests. The tests are completely free. Orders will usually ship in 7-12 days. For further information go to https://www.covidtests.gov/.

When the January meeting was cancelled, a virtual Zoom presentation of the Partners In Care (https://partnersincare.org/) program was made to our members by Ms. Hongwei Xu, Site Director, Partners In Care, Maryland, Inc. For those who did not participate in this, Partners In Care is a local service organization that offers programs and services that enable older adults to remain independently in their homes. Some service examples include transportation to and from appointments, handyman small repair jobs in the home, support with working though sometimes difficult applications and forms that may be required to access other senior services. The organization, founded in 1993, bases its mission on "neighbor helping neighbor". This mission is accomplished by a unique service exchange where members volunteer their time and talents to help each other and can "bank" these hours for a future needed use.
