Legislative Report (David Carmack • 240-578-4965)

You should follow the news on lifting the Federal Government's debt limit and encourage your Senators and Representative to vote to lift the debt ceiling. If the debt ceiling is not lifted, the Federal Government will be unable to pay the amounts that it owes, e.g., pensions, Social Security, Medicare, Medicaid, and defense just to mention a few. Lifting the debt ceiling does not incur new spending, but only enables the Federal Government to pay what previous Congresses have already enacted. Two bills that failed to pass in the last

Congress have been reintroduced in this Congress: The Social Security Fairness Act, H.R. 82, and The Chance to Compete Act, H.R. 159. The first bill would repeal the Windfall Elimination Provision and the Government Pension Offset. These reduce the Social Security benefits for Civil Service Retirement System (CSRS) annuitants receiving a CSRS pension. The second bill would improve cross-agency hiring by allowing agencies to share assessments about prospective employees with other agencies and would focus on the applicant's relevant experience and skills rather than on self-rating and degrees. NARFE Maryland is continuing to seek the Maryland legislature to decouple the Maryland state income tax deduction from the Federal standard deduction.

Alzheimer's Report (Kathy Siggins • 301-829-2462)

In December both chambers in Congress worked hard to finalize the FY2023 budget through the passage of the Consolidated Appropriations Act of 2023. With the strong support of Alzheimer's advocates, the bipartisan Congressional leaders were able to prioritize Alzheimer's and other dementia in the package. The National Institutes of Health (NIH) received an increase of an additional \$2.5 billion bringing their total budget for FY2023 to \$47.5 billion. Congress also included an increase of \$226 million bringing the total to over \$3.7 million for Alzheimer's and dementia research funding at the NIH, and \$33 million to continue implementation of Building Our Largest Dementia Infrastructure (BOLD) for Alzheimer's Act at the Centers for Disease Control and Prevention (CDC). This is a huge win for the Alzheimer's cause!

On January 22, 2023, the U.S. Postal Service (USPS) raised the price of First-Class postage to.**63 cents**. Although the price of an Alzheimer's Semipostal stamp remains at **75 cents**, the additional 3 cents per stamp will be deducted from the Alzheimer's cause. The price for a sheet of 20 Alzheimer's stamps remains at \$15. Please continue to buy and use the Alzheimer's Stamp.
