PRESIDENT'S MESSAGE

The hustle and bustle of the holidays is over. It's time to take a breath and look towards the New Year and all of the opportunities that it will bring. As I write this column we are still waiting to see if we are to go over the "fiscal cliff". Hopefully our representatives in Congress won't have just "kicked the can down the road", but will instead have created a fiscal situation where the burdens are shared in a fair and equitable manner.

If you are interested in seeing the impact of the various proposals on your financial situation, the Urban Institute, a Washington, DC-based think tank, has unveiled a new interactive toolkit. It answers questions such as: How does the fiscal cliff affect Social Security, Medicare and Medicaid? What changes to these programs are proposed and whom would they affect? What are the consequences of paring down tax deductions and of the mandatory spending cuts that are part of the cliff? Answers are available at: http://www.urban.org/fiscal-cliff. Recently there was an article in the Washington Post, written by a hospital nurse on the problems she and her husband encountered as he transitioned from an acute care hospital to a rehab facility and then to home, Records didn't always travel with him as he was transferred from place to place and neither did his history at each facility. His return home was filled with anxiety as she became the caregiver, trying to understand her new role and what she was being told by the various medical personnel. This process is an on-going concern for many folks. Our January speaker, Heather Kirby, Director Care Management with Frederick Memorial Healthcare System, will be

discussing what is being done locally to address these issues. Hospitals have always wanted the best for their patients. The Affordable Care Act has added serious incentives, including penalties for hospital readmissions, all aimed at improving outcomes for patients. Come, listen and ask your questions as these changes are presented during the program on **January 18**th.

Just in case, do remember our bad weather policy – if Frederick County schools are closed for weather the luncheon is cancelled and the checks are shredded.

Mobile I&A Initiative

Mobile information and assistance at senior centers will provide assistance with topics ranging from legal documents, consumer education, and financial exploitation. This Mobile I&A initiative is scheduled to begin in January as representatives from MD Food Bank, Energy Assistance and the Department of Aging visit each senior center monthly to provide complete information, answer questions and applications for SNAP (food stamps), Energy Assistance, and Medicare Subsidies. People are encouraged to schedule an appointment, but walk-ins are welcome. The regular monthly schedule will be 10:00AM at: Frederick Senior Center on 1st Tuesday, Urbana Senior Center on 2nd Wednesday, Emmitsburg Senior Center on 3rd Thursday, and Brunswick Senior Center on 4th Friday. Because of the New Year's Day holiday, the January visit to the Frederick Senior Center will be held on the second Tuesday, January 8th. Federal - The 113th Congressional Session will begin on January 3, 2013 with the swearing in of Representative John Delaney (D-MD), 6th Congressional District. Mr. Delaney can be reached at 202-225-2721 and will be located at 1623 Longworth House Office Building, Washington, DC 20515. Due to redistricting members of Chapter 409 are also represented by Representative Chris Van Hollen (D-MD), 8th Congressional District. Mr. Van Hollen can be reached at 202-225-5341 and is also located in the Longworth House Office Building.

State – On January 9, 2013, the Maryland General Assembly session will begin at noon. The session will run through April. The state has 47 districts represented by 47 Senators and 141 Delegates
