

CO-PRESIDENTS' MESSAGE Elinor Abrell (301-831-8753)

For more than twenty years Chapter 409 has supported the Volunteer Income Tax Assistance (VITA) program whose mission is to prepare federal and state income tax returns at no cost for low/moderate income persons and senior citizens. Volunteers in the program do not need an accounting background; most have at least minimal tax knowledge coming from simply doing their own returns. Internal Revenue Service (IRS) provides loaner laptop computers, the software that is used, and training materials. Volunteers must complete a study regimen, pass tests to be certified preparers, and agree to adhere to strict rules of conduct and ethics.

This year our VITA group had fifteen volunteers, many with 10-20 years involvement in the program and four who joined just this year. Tax Season begins in November when volunteers begin "hitting the books," using both IRS printed study materials and on-line resources. During January a training session is held, which is a full week (9 am-4 pm daily) of review of tax law and hands-on computer practice. Chapter 409 funds this training session in the form of a donation to the facility used, which this year was VFW Post 3285 on the Golden Mile. Returns are by appointment at one of these sites: Frederick Senior Center, Department of Social Services, and Glade Valley Food Bank (Walkersville). Next year we plan to add the Thurmont Library as another site.

Our volunteers this year completed 900 federal returns as well as 900 state returns. We find that the clients we serve are most appreciative of the service we offer, which is rewarding in itself. If these clients had gone to professional preparers, they would have paid a minimum of \$150 for just a simple return. A conservative estimate is that a savings of about \$150,000 was seen here. LEGISLATIVE REPORT Kathy Siggins (301-829-2462)

Medicare Part B Hold Harmless: Last year, Medicare Part B enrollees who are not held harmless faced a 52 percent increase in their Part B premiums. As part of the budget agreement, a compromise was reached which raised premiums for those not held harmless the same amount they would have risen had there been a COLA. This was a 15 percent increase. Looking to 2017, there are three scenarios that we are watching:

- If there is no COLA, then the agreement reached at the end of last year holds. Those held harmless stay held harmless. If Medicare Part B premiums rise, those not held harmless will likely see their premiums rise to the new amount, but not more.
- If there is a COLA large enough to cover the increased cost of Medicare Part B, then protections of the agreement will kick in and all Medicare Part B beneficiaries will pay the new higher rates, plus the \$3 surcharge.
- The bigger, more concerning issue is if there is a small COLA that does not cover the Medicare

Part B increase. If that is the case, those not held harmless could see a large increase - possibly as large as the threatened 52 percent we saw last year.

The Medicare Trustees Report will tell us the estimated Medicare Part B rates for next year. This will kick off any necessary NARFE advocacy. As of right now, it's likely there will not be a COLA next year but it is still early. Because there was no COLA last year, the baseline for an increase remains the third quarter of 2014. NARFE has been working on this issue since the agreement was reached last November. This is an issue that retirees will continue to face and it is not right for it to be resolved on a year-to-year basis. NARFE continues to advocate for a permanent, fair solution. In 2000, the Semipostal Authorization Act granted the U.S. Postal Service (USPS) authority to issue and sell five fundraising stamps called semipostals to advance

such causes as it considers to be "in the national public interest and appropriate." The 10-year program was suspended indefinitely due to the tragic events of 9/11. On April 20, 2016, the provisions governing the Postal Service's discretionary Semipostal Stamp Program were revised and approved to reauthorize the program. The USPS will begin accepting proposals for causes on May 20, 2016. I will be re-submitting my proposal in support of Alzheimer's disease, along with the remaining signatures collected in a nationwide campaign that generated a total of 84,777 signatures.
