If you are not willing or able to volunteer on committees, then I need all of you, Chapter 409 members, to show your support by attending our luncheons beginning in May and June. Please do this for the good of our chapter.

We have a very full agenda for our May 15th luncheon: Installation of Officers; a performance by The Golden Tones; and, our Annual Memorial Service. Chapter 409, in addition to supporting Alzheimer's research, selects a local charity each year to support with a donation. A check will be presented to this year's recipient, Friends of Meals on Wheels. I hope to see everyone there and please remember to bring a friend.

LEGISLATIVE REPORT Kathy Siggins (301-829-2462)

The House (228-199) and Senate (52-46) passed budget resolutions in March that cut billions of dollars' worth

of pay and benefits from federal employees and retirees. The House budget proposes a \$318 billion in "savings" by raising the cost of health insurance for all FEHBP participants, eliminating federal jobs by reducing the federal workforce by 10 percent through attrition and, increasing retirement contributions for all current employees. The legislation decreases the rate of return on the Thrift Savings Plan's government securities fund (G Fund) from an interest rate of 1.88 percent to 0.01 percent, basically making it worthless and, encourages the elimination of the Federal Employees Retirement System (FERS) annuity supplement. Senate budget resolution, while less specific in how it would cut costs, still asks the federal community for \$170 billion toward deficit reduction. Republicans that joined the Democrats in voting NO were Senators Ted Cruz (R-TX) and Rand Paul (R-KY). I'd like to think they did so because it unfairly attacking the federal community. What do you think?

PROPOSED CHAPTER DUES INCREASE

Chapter 409 membership has decreased by nearly 300 members in the last 6 years. Associated with that decline is a decrease in the income from those members' chapter dues. Unfortunately, that loss has now reached the point where it does not even cover the cost associated with publishing and mailing the chapter's booklet and newsletters to our members.

Back in January the Chapter's Executive Committee had started a discussion on the financial status of the Chapter, including the results of the questionnaire included in the December newsletter. We again met on March 26th to continue that discussion. Coming out of that meeting was a decision to raise the annual Chapter membership dues from \$8 to \$9. This change will be voted on at the May 15th meeting and, if accepted, will be payable on the anniversary date of your National dues.

Ideas for Improving Chapter Finances

Members submitted many ideas for improving the chapter's finances, including:

Increasing the price for the monthly luncheon meetings, with the extra going to the chapter.

Publicizing the chapter to target audiences (such as AARP, active employees at Fort Detrick and other federal installations) to increase our membership numbers.

Limiting hard copy mail-out of the newsletter only to those members without email or charging a member extra to receive the newsletter in hard copy.

Increasing chapter dues.

Hosting annual or occasional fundraising events (such as bingo, dinners, dances, raffles, yard sales, bake sales, and trips).

Having a white elephant table at luncheon meetings.

Selling NARFE and/or Chapter 409-related merchandise (such as lapel pins, hats, T-shirts, pencils).

Selling other merchandise (such as American/Maryland flags, used books, other used items, holiday items).

Offering services with a portion or all profit going to the chapter.

Views On Monthly Luncheon Meetings

The survey found that members who attended chapter luncheons at least four times in the past year expressed overwhelming satisfaction with their cost, food, facilities, topics, and speakers. Almost all frequent attendees who responded to the survey are willing to pay "a dollar or two more" per luncheon to improve the chapters' finances. A solid majority of these frequent attendees are willing to pay "a dollar or two more" per luncheon for better food and facilities.

Although the survey was distributed with the newsletter, only three members who attended our luncheons three or fewer times in the past year responded. With so few responses from such members, we cannot draw any valid conclusions about their views, other than to conclude from the very low response rate that the luncheons are not an important reason for their belonging to the chapter.

The board would like to thank all members who shared their ideas and opinions or responded to our request for volunteers. We are carefully considering your ideas and opinions.
