An offer to save you 15 %?

As a result of some confusion concerning the wording of the various renewal notices folks are receiving from National Headquarters, I would like to make you aware of a savings offer – that is to pay your NARFE dues through the "Dues Witholding Program". If you sign up, OPM will extract \$3.50 each month from your annuity check and send that \$3.50 straight to NARFE Headquarters. You will have saved 15% off the regular yearly dues and also, no more check writing is required of you. I switched long ago, and recommend it for everyone. LEGISLATIVE REPORT

Federal retirees will receive a 1.7% cost-of-living adjustment (COLA) to their civil service annuities beginning in January 2013. COLAs for federal retirement annuities, military retiree annuities and Social Security, are determined using the Consumer Price Index for Urban Wage Earners and Clerical Workers (CPI-W), which is calculated by economists and statisticians with the Bureau of Labor Statistics

The U.S. Postal Service has offered a huge buyout

that could drive the largest single postal workforce exodus in two decades. The deal, combines a \$15,000 buyout with an early retirement package for longer-serving workers, and is open to virtually all of the 187,700 clerks, drivers and other career employees represented by the American Postal Workers Union.

Congress is scheduled to go back into session Nov. 13, to deal with a long list of policy and taxation issues that were left unfinished, to campaign for re-election.
