NARFE 409 LUNCHEON MEETING

Friday, Nov. 18. Doors open at 11:00 a.m. Program will be Mr. Bill Gray, Account Manager, FEHBP Account Management & OPM Relations from BlueCross/BlueShield speaking on changes in the FEHB program. Mr. Gray expects that representatives from Kaiser, Aetna, Unitedhealthcare (includes MD-IPA) and GEHA will attend the November luncheon.

CO-PRESIDENTS' MESSAGE Elinor Abrell (301-831-8753)

Last year Senator Ronald Young (District 3-Frederick) introduced into the Maryland General Assembly a bill titled "Income Tax - Subtraction Modification -Retirement Income" (2016SB005) for the purpose of altering the subtraction amount allowed on the State income tax return for certain retirement income of individuals at least 65 years of age or totally disabled, or whose spouse is disabled. This bill would have repealed and reenacted with amendments, portions of the existing MD Tax Code. The bill never made it to the floor of the General Assembly and Sen Young plans to reintroduce it in the 2017 session.

For 2015 MD tax returns, the allowable pension exclusion was \$29,200, and has historically increased by \$700 annually for a number of years. Should Sen. Young's bill pass in the 2017 Assembly, allowable pension exclusion would increase to \$33,000 in 2018, and then in \$7,000 annual increments for six more years, capping out at \$75,000 allowable exclusion in 2024. Generally speaking, retirement income that can be excluded is defined as income derived from a qualified employee retirement system and does not include IRAs and annuities. This bill would definitely benefit Maryland retirees, many of whom move out of state upon retiring, complaining that MD taxes are

simply too high and they can live cheaper elsewhere. Sen. Young is reaching out to all retiree groups to garner support for this bill. Phone calls, emails, and letters to his office are needed—numbers are so important when trying to get any legislation passed. More information on this bill will be coming in the near future, and most definitely a large contingent of supporters present when he does introduce the bill in the General Assembly would carry a strong message for its passage.

LEGISLATIVE REPORT Kathy Siggins (301-829-2462)

A total of 75 organizations sent a letter to lawmakers on September 27, 2016, asking them to find a solution to the sharp expected increase in Medicare Part B premiums that was forecast in the 2016 Medicare Trustees report. The letter cited a figure from the report suggesting that premiums could rise by as much as 23% for nearly 30% of beneficiaries. This, coupled with the likelihood of little to no COLA next year, means that retirees could be facing a difficult situation. In the letter, the organizations state that "According to the 2016 Medicare Trustees Report, Part B premiums will increase significantly for nearly 30 percent of beneficiaries. It is estimated that 2017 Part B premiums could increase to an estimated \$149 per month, which is a significant increase over the standard 2016 Part B premium of \$121 per month. The trustees also predict that this increase will be accompanied by a hike in the Part B deductible-up to \$204 from \$166."

Last year's Bipartisan Budget Act of 2015 allowed the Part B monthly standard premium to increase by 16 percent to \$121.80 for those Part B enrollees whose premiums were not deducted from their Social Security benefits, but that increase was far less than the \$159.30 amount initially projected by Medicare actuaries. The legislation also said that there would be no increase in premiums in 2017 provided that there was no COLA, but a small COLA, which could be as little of 0.2 percent, would allow Medicare trustees to impose at least a 22 percent increase in the standard premium for those not protected by the hold harmless clause.

The letter asks that Congress support an extension of the solutions included in the Bipartisan Budget Act of 2015 and extend the protections of the hold harmless provision to all beneficiaries. While most CSRS retirees are affected, other groups feeling the impact include individuals turning 65 this year, state and local government retirees not covered by Social Security, and state Medicaid programs. Groups signing the letter include AARP, AFL-CIO, America's Health Insurance Plans, the National Active and Retired Federal Employees Association, and many public sector unions.

ALZHEIMER'S REPORT Kathy Siggins (301-829-2462)

NARFE launched its National Walk to End Alzheimer's Team this year and has recruited 220 teams to take part in some of the 600 walks nationwide. NARFE's goal is to raise \$50,000 in 2016, to support families in local communities who are living with Alzheimer's. Donations will continue to be accepted through the end of November which is National Alzheimer's Disease Awareness Month.
