PRESIDENT'S MESSAGE Elinor Abrell (301-831-8753)



Information learned at this meeting is a valuable tool in assessing offerings of various carriers to determine which best meet our individual health needs. Any changes in premiums may be made during Open Season, which begins on Monday, November 12 and ends on Monday, December 10. Please note that the November issue of *narfe magazine* has a detailed report on Open Season with informative articles as well as a chart listing 2019 premiums.

Speaker for this program will once again be David Hurka, from Blue Cross/Blue Shield. David will provide updated information on the impact of OPM on benefits and how the various carriers are responding. Representatives from four other carriers have been invited to attend our meeting, but we do not yet know for certain which ones will be present. Please know that guests are most welcome to come just for the program, which will start at 1:00 p.m. We would like to have your company for lunch, but it is not a requirement.

Over 1,000 walkers took part in the Western MD Walk to End Alzheimer's in Frederick on Sunday, October 14, 2018, raising more than \$223,000 for the Alzheimer's Association. The funds will be used to help local chapters provide supportive care to families in our communities and support research. The Alzheimer's Association will continue to accept donations through the end of the year.

LEGISLATIVE David Carmack (240-578-4965)

In line with the Social Security COLA for 2019, the COLA for 2019 for CSRS retirees is 2.8 percent. The COLA for 2019 for FERS retirees, under existing law, is 2 percent. NARFE opposes the distinction. NARFE also opposes the method used to calculate the COLAs as not reflecting the actual spending habits of Americans over age 62. NARFE has been working to change the method of the COLA calculation through legislation (the CPI-E Act of 2017). But NARFE faces an uphill battle considering the recent remarks of the Senate Majority Leader to focus on entitlement reforms to decrease the increasingly large deficit.

Legislation for governmental reorganization has now advanced from the Senate Homeland Security and Governmental Affairs Committee to the Senate. NARFE has grave concerns about certain aspects of the proposed legislation. Among those concerns is the transfer of federal personnel policy from the Office of Personnel Management to the Executive Office of the President. Under the proposed legislation, the Office of Management and Budget is given two years to submit a reorganization plan, which plan must then be approved by Congress. Companion legislation in the House has not been considered.

VOLUNTEERS NEEDED FOR VITA PROGRAM

The Volunteer Income Tax Assistance program is in need of volunteers and would welcome inquiries from any person interested in participating. An accounting background is not necessary, but it is helpful to have some basic tax knowledge along with at least average computer skills. IRS provides training materials for study, sets the rules and regulations under which volunteers work, and requires each person to pass qualifying tests. The Frederick VITA group last year did approximately 900 federal and state returns at four sites. Volunteers who participate find this to be a very rewarding endeavor.
