### CO-PRESIDENTS' MESSAGE Elinor Abrell (301-831-8753)

Those who purchased FTLCIP policies intended to help pay for future health care needs are indeed shocked by the recent announcement of premium increases and now face difficult choices as they struggle with available benefit and cost options. In July, OPM announced that a new seven year contract was awarded to John Hancock Life & Health Insurance Co, sole insurer of FTLCIP since 2009, and that, along with this, premium costs would rise by an average of 83 percent. Apparently the actuaries, those insurance professionals whose job is to study statistics of life expectancies, costs, and future projections got this all wrong and now the policy holders are left to bear the burden. It has been established that, without an increase in premiums, the program would not be able to cover future claims costs.

NARFE National President Richard Thissen has issued a press release expressing anger and outrage over these shocking premium increases. NARFE Legislative Department has contacted congressional offices and the appropriate Senate and House committees to request hearings to look into why this situation occurred as well as to mitigate the possibility of similar future premium increases. Both Rep. John Delaney (D-6) and Rep. Chris Van Hollen (D-8) have issued statements and written to these committees.

The NARFE website (narfe.org) has added a dedicated page to FTLCIP to keep members fully informed and updated on premium increases. Link to the Legislative Action Center where you will find an action letter that can easily be completed and sent to your legislator. Members of Congress are beginning to publicly comment, so it is important to contact them at this time to add your support to NARFE's call for hearings

#### LEGISLATIVE REPORT Kathy Siggins (301-829-2462)

The Maryland Federation of Chapters (NARFE/MD) of the National Active and Retired Federal Employees Association (NARFE) is partnering with AARP Maryland to host a Congressional District 8 and Senate Candidates' Forum on Saturday, September 17, 2016 from 1:00 to 4 p.m. at the Bioscience Education Center in the Hercules Pinkney Life Sciences Park on the Germantown Campus of Montgomery College. All are

welcome so please mark your calendar to attend.

Premiums for Federal Long Term Care Insurance are set to rise by an average of 83% beginning November 1, 2016. For those paying premiums from their annuities, the first increased premium payment will be reflected in the December 1 annuity payment. NARFE is urging the Senate Special Committee on Aging, the Senate Homeland Security and Governmental Affairs Committee and the House Committee on Oversight and Government Reform, to hold hearings "to seek information on the reason for these new, massive increases and to discuss policy options to mitigate the effect of premium increases now and in the future." President Thissen also asked the committees to press the Office of Personnel Management for an extension of September 30 decision deadline. the


