November for NARFE always means that it's now time to look at health benefits, meaning what news on that front is coming from Office of Personnel Management (OPM) and what impact this may have on current, as well as future, benefit plan(s). As you know. OPM decisions affect all carriers, determining what benefits must be offered, which then impacts rates for these services. Once again Chapter 409 is honored to have David Hurka. from BlueCross/BlueShield as our speaker, bringing and clarifying the latest information from OPM. This year there are significant changes in Medicare, coming from Congressional legislation regarding prescription drug coverage. OPM is addressing this through an integration of Federal Employee Health Benefits (FEHB) and Medicare pharmacy benefit design. This is a complex maze, and we are fortunate to have Mr. Hurka to explain and offer guidance.

Open Season, the period between **Monday**, **November 13 through Monday**, **December 11**, is when federal employees and retirees may make changes to or update their health benefit plan(s). Now is the time to review your current plan and gather information about this new Medicare coverage and determine your needs for the coming year. Perhaps exploring and comparing offerings from other carriers will provide valuable information as you make these important decisions. In addition to Mr. Hurka, representatives from four other carriers have been invited to give a brief overview of their company's benefit plans. All will be available for questions following the meeting.

As always, NARFE is a valued source of information during this time and encourages members to research and navigate through the array of available options and make informed decisions that meet both need and budget. The November issue of *narfe* magazine is always dedicated to FEHB. Through the website <u>www.narfe.org</u> a number of very informative webinars are offered that may be helpful in narrowing a choice.

Legislative Report (David Carmack • 240-578-4965)

Unless Congress authorizes by November 17, 2023, spending for the Federal Government's Fiscal Year 2024, and the President signs such authorization, the Federal Government will shut down. Federal Government pensions and Social Security payments will continue even if the Federal Government shuts down. The 2024 cost-of-living adjustment (COLA) will provide a 3.2% increase to Civil Service Retirement System (CSRS) annuities and to Social

Security benefits and a 2.2% increase for Federal Employees Retirement System (FERS) annuities.

The House of Representatives passed (394 for, 1 against) a bill (H.R. 4504) to relax educational requirements for federal cyber security employment. Legislation has been introduced in the House of Representatives (H.R. 5883) and the Senate (S. 3029) to increase the death gratuities and federal allowances for federal employees who lose their lives while serving the nation. Legislation has been introduced in the Senate (S. 3015) to solidify current telework policies and improve management and transparency of telework programs.

The Office of Personnel Management (OPM) issued a proposed rule designed to reinforce the merit-based, nonpartisan civil service. This proposed rule would allow federal employees to keep their existing job protections, which protections could be taken away only if the employee gives them up. This proposed rule adds a procedural roadblock for any future administration looking to undermine merit-based protections through a rewrite of Schedule F or similar efforts.

The Walk to End Alzheimer's was a huge success with 145 teams registered and close to 1,000 participants raising \$261,963 in donations. Team HOPE raised \$8,570 putting us in 2nd place on the National Team website, and me as the Top Individual Fundraiser with \$7,350. Donations will continue to be accepted through the end of

the year, however, NARFE is setting a deadline of December 25th so that it can be counted towards our national goal of \$100,000 for the 2023 Walk.
