#### President's Message (Elinor Abrell • 301-831-8753)

At the January luncheon meeting speakers from the Frederick County Office of Register of Wills gave us an explanation of how this process works, as well as some very helpful "how to" guidelines. This month we will hear **Brad Young**, CFP (Certified Financial Planner) give a presentation on tax strategies for seniors. Both topics can be overwhelming and confusing but know that NARFE has available some very informative webinars that are worth a look. A very timely webinar

is Tax Planning for Federal Retirees; perhaps reading this could be a homework assignment to prepare for the program. A second webinar of interest is Estate Planning: Strategies for Feds. The library of NARFE webinars is very easily found on their website – click here for access.

The 2024 90-day legislative session of the Maryland General Assembly is now convening in Annapolis (January 10 - April 8). Paul Schwartz, NARFE MD Federation State Legislative Committee Chair, is once again advocating for legislation to benefit the seniors of Maryland, most importantly, tax relief. Paul reports that two tax relief bills are to be introduced during this session. The first, sponsored by Sen. Benjamin Brooks (D - Baltimore County) is a bill seeking a senior tax credit, and the second, sponsored by Delegate Robin Grammer (R – District 6, SE Baltimore County) is a bill to repeal state taxation of retirement income in Maryland. NARFE, of course, supports these legislators. It is widely known that Maryland's economic recovery has been slow, and is expected to remain so, due to the decline in population growth. Paul states that while Maryland sees a population decline, other states around us are seeing a steady population increase, especially among retirees. As a large percentage of Maryland's revenue is generated from state income taxes, it becomes highly unlikely that any bill to reduce tax income will ever get out of Committees to the floor. Paul's words: "We can't get tax relief for retirees because of loss of revenue resulting from population decline, yet the population decline, to a degree, can be tied to the high cost of retiring in Maryland." A Catch 22 situation indeed.

February is the month that starts the process of electing Chapter officers and members of the Executive Committee for the next year. A Nominating Committee, consisting of Chuck Caloia, Chair, and members Pam Ogasawara and Gerry Blessing, will present a proposed slate of candidates at the February meeting. Finding people willing to consider an office or Executive Committee position has become a daunting task. NARFE, at all levels, must have member participation and support to remain a strong and viable organization. Surely there are Chapter members who are willing to step up and give a bit of time to ensure that Chapter 409 can continue. Sadly, some NARFE chapters have either dissolved or combined with another chapter due to declining membership or lack of support. We cannot let this happen!
