

## Welcome to NARFE Chapter 409 Frederick, Maryland

#### About Chapter 409

- **Our History –** Chapter 409 was organized on December 7, 1967, in order to join with other federal employees in protecting hard-earned benefits. We met first in members' homes, then, as our membership grew, meetings were moved to a local fire house and then to local service clubs. Currently, meetings are held at Golden Corral.
- **Our Members –** There are about 300 members in our Chapter. Regular monthly meeting attendance averages approximately 40 members. Members are mostly retirees who have worked in the Frederick, D.C., and surrounding areas. There are many agencies and activities represented by our members.
- Services to the Community We've donated nearly \$25,000 to local charities that benefit senior citizens. We've also donated \$19,775 for research seeking a cure for Alzheimer's disease at the national level and another \$19,415 to help provide local treatment for those afflicted with the disease and support to their families.

Chapter 409 supports VITA (Volunteer Income Tax Assistance program), in cooperation with the Internal Revenue Service. VITA provides free preparation of federal and state income tax returns for low/moderate income persons and senior citizens.

Chapter 409 is a member of the Maryland Federation of Chapters, NARFE. Two Chapter 409 members have served as Federation president, and many have served on Federation committees.

Chapter 409 initiated the national drive to have the Postal Service issue an Alzheimer's semi-postal stamp to raise awareness about the disease and provide research funds to help discover a cure.

We serve our members:

- By providing assistance and information about retirement, retirement options, and benefits.
- By providing advice and assistance to a survivor upon the death of a federal employee or annuitant.

We serve the larger federal community by being advocates for pending legislation which supports federal employees, retirees, and survivors.

### Chapter 409 Meetings

Monthly luncheon meetings are held at the Golden Corral Buffet & Grill, 5621 Spectrum Drive in Frederick on the 2<sup>nd</sup> Tuesday of the month from September through June. Gathering, social time, and lunch take place from 11:00 AM to 12:30 PM, followed by a program featuring a speaker or presentation on a variety of topics.

# <u>Snow Policy</u>: If Frederick County schools are closed due to weather, the luncheon is cancelled. If County schools are delayed but open by 11:00 AM, the luncheon will be held as scheduled.

During gathering time members and guests have the opportunity to purchase tickets for two types of drawings:

\* One is a 50-50 raffle where half the funds taken in goes to support the annual chapter donation to a local charity and the other half is distributed as prizes, generally \$5-\$10 per winner.

\* The second type of raffle is used to support Alzheimer research. Members bring in baked goods, either homemade or purchased. Tickets are drawn and each person with a winning ticket gets to choose a baked item to take home.

### Officers

Chapter 409 has an Executive Committee which meets monthly (currently over Zoom) to ensure continued success of the chapter. Elections are held in April. The Executive Committee is composed of:

President; 1<sup>st</sup> Vice President (Membership); 2<sup>nd</sup> Vice President (Legislation); Treasurer; Recording Secretary; Corresponding Secretary; Service Officer; Chaplain; Newsletter Editor; Webmaster; Members-at-Large, who have a variety of duties and responsibilities; Immediate Past President.
