**Legislative Report** (David Carmack • 240-578-4965)

The House has passed, by a vote of 327-75, The Social Security Fairness Act (HR-82), a bill that repeals the Social Security Government Pension Offset (GPO) and Windfall Elimination Provision (WEP). Now the bill goes to the Senate, which has a similar bill (S-597) with 62 cosponsors. It is now up to the Senate Leadership to bring this matter to a vote. Unless this is done by the end of this Congress, the quest to eliminate the GPO and WEP will have to start from scratch.
